### School Fees: Preschool - 6 Grade

- The school provides a daily snack for all students for a one-time \$90 fee.
- The school provides milk at lunch for all students for a one-time \$90 fee.

**Scholarships** - We have two types of scholarships available. The award amount is based on income and household size. ***Good Shepherd Christian Academy has a sliding scale used to determine scholarships awarded if funds are available. Please see the attached table.***

**Scholarship Granting Organization (SGO) - AVAILABLE TO PREK/4YO** Good Shepherd Christian Academy partners with the Institute for Quality Education to receive scholarships that make private schools more affordable. These tax credit scholarships are funded by donations. The individuals and businesses that donate to the scholarship receive a tax benefit. Students must be residents of Indiana and their family's income guidelines should match our scholarship table. Students in Kindergarten Prep are eligible. Students may receive both SGO and School Choice funds if tuition and school fees are not exceeded. The awarded amount depends on available funds and will be determined yearly by the school administrator and a school board representative. **Shepherd's Fund - AVAILABLE PRIMARILY TO 3YO** Donations fund the Shepherd's Fund and assist families and students in many ways including snack and tuition assistance. *Priority is given to students whose families fall at 100% or below the Federal Free and Reduced Lunch Income Guidelines.* The awarded amount depends on available funds, and applications will be reviewed/awarded by the school administrator and a school board representative.
